

This Addendum (the "Addendum") applies to and is made a part of the Order Form entered into between PeopleNet Communications Corporation dba Trimble Transportation, a Trimble company, with principal offices at 4400 Baker Road, Minnetonka, MN 55343 ("Trimble", "our," "we", and "us") and the customer named on that Order Form ("Customer," "you" and "your") (each, a "Party," and together, the "Parties") which Order Form expressly incorporates by reference this Addendum, the Master Terms and Conditions (the "Master Terms"), and Supplemental Terms for Telematics SaaS with Trimble-Sold Hardware (the "Supplemental Terms"), as well as any other terms referenced on the Order Form (the Order Form with the incorporated terms, any Statements of Work, and any other amendments, addendums, modifications, exhibits and schedules to the foregoing collectively, the "Agreement"). This Addendum will have no independent force or effect except as incorporated by reference into an Order Form. By initialing or executing an Order Form, you (by your authorized signatory) confirm that you have read and accept all incorporated terms. Capitalized terms used but not defined in this Addendum shall have the meanings given to them elsewhere in the Agreement. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Optional Subscriptions. For each Trimble-Sold Hardware device specified on the Order Form, as an add-on Subscription we will provide you with the an extended warranty for that device as set forth below. The quantity and monthly subscription fee for each Extended Warranty add-on Subscription shall be set forth in the Order Form; Extended Warranty subscription fees shall be per Trimble-Sold Hardware device per month. You will be invoiced in the currency set forth in the Order Form. Billing commences upon the Billing Commencement Date of the telematics Subscription for each Trimble-Sold Hardware device for which an Extended Warranty add-on Subscription is purchased.

Service

On-Board Computer ("OBC") Extended Warranty. Extends the non-transferable product warranty on each Trimble-branded on-board computer, specifically excluding Trimble PCG (PeopleNet Connected Gateway) and T511 Devices, purchased by you via an Order Form on which a corresponding quantity of OBC Extended Warranties are purchased, until the earlier of (a) the five (5) year anniversary of the device shipment date, or (b) the termination of the service subscription on such device (excluding suspensions and safety stock devices). Extended warranty does not cover displays; options and accessories; product add-ons such as keyboards, in-cab displays, vehicle management adapters, tablet cradles, and satellite modems; DVRs and cameras; or Trimble PCG (PeopleNet Connected Gateway) Devices. Abuse or misuse is not covered. The warranty terms and limitations set forth in the Agreement shall apply to and govern devices covered by the OBC extended warranty.

OBC w/Integrated Display Extended Warranty. Extends the non-transferable product warranty on each Trimble-branded on-board computer with an integrated display (e.g., Duo) purchased by you via an Order Form on which a corresponding quantity of OBC w/Integrated Display Extended Warranties are purchased, until the earlier of (a) the five (5) year anniversary of the device shipment date, or (b) the termination of the service subscription on such device (excluding suspensions and safety stock devices). Extended warranty does not cover other OBCs; displays; options and accessories; product add-ons such as keyboards, in-cab displays, vehicle management adapters, tablet cradles, and satellite modems; DVRs and cameras. Abuse or misuse is not covered. The warranty terms and limitations set forth in the Agreement shall apply to and govern devices covered by the OBC extended warranty.

Display Extended Warranty. Extends the non-transferable product warranty on each Trimble-branded display unit purchased by you via an Order Form on which a corresponding quantity of Display Extended Warranties are purchased, until the **three (3) year** anniversary of the display shipment date. Extended warranty does not cover BLU2; PD.4s; on-board computers; consumer-grade equipment; options and accessories; product add-ons such as keyboards, in-cab displays, vehicle management adapters, tablet cradles, and satellite modems; or DVRs or cameras. Abuse or misuse is not covered. The warranty terms and limitations set forth in the Agreement shall apply to and govern displays covered by the display extended warranty.

This Addendum is incorporated by reference into and is made a part of the Agreement. In the event of a conflict between a term or provision in this Addendum and a corresponding term or provision in the Agreement, this Addendum controls. Except as otherwise modified or supplemented by this Addendum, all terms, conditions and provisions of the Agreement shall remain in full force and effect.
