

This Addendum (the “**Addendum**”) applies to and is made a part of the Order Form entered into between **PeopleNet Communications Corporation dba Trimble Transportation**, a Trimble company, with principal offices at 4400 Baker Road, Minnetonka, MN 55343 (“**Trimble**”, “**our**”, “**we**”, and “**us**”) and the customer named on that Order Form (“**Customer**”, “**you**” and “**your**”) (each, a “**Party**,” and together, the “**Parties**”) which Order Form expressly incorporates by reference this Addendum, the Master Terms and Conditions (the “**Master Terms**”), and Supplemental Terms for Telematics SaaS (the “**Supplemental Terms**”), as well as any other terms referenced on the Order Form (the Order Form with the incorporated terms, any Statements of Work, and any other amendments, addendums, modifications, exhibits and schedules to the foregoing collectively, the “**Agreement**”). This Addendum will have no independent force or effect except as incorporated by reference into an Order Form. By initialing or executing an Order Form, you (by your authorized signatory) confirm that you have read and accept all incorporated terms. Capitalized terms used but not defined in this Addendum shall have the meanings given to them elsewhere in the Agreement. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **Safety Analytics Service.** The Trimble Safety Analytics service (the “**Safety Analytics Service**”) aggregates driver data from your fleet collected through Video Equipment and from then-current third party data partners, such as our CSA data provider (the “**CSA Data Provider**”), and presents such data through an online portal (the “**Safety Analytics Portal**”) for use by you to highlight and remediate safety issues within your fleet. The Safety Analytics dashboard only includes drivers that are active in the Management Portal and FMCSA database under the DOT number(s) provided. For the term of this Addendum, we grant to you a limited, non-exclusive, non-transferable, non-sublicensable right and license for your drivers* to access and use the Safety Analytics Service set forth in the table below. Billing will commence upon activation of the Safety Analytics Service. You may terminate this Addendum and all add-on Subscriptions to the Safety Analytics Service effective as of the end of a calendar month by providing at least sixty (60) calendar days prior written notice of termination to us. As of the termination of this Addendum, we will cease provision of the Safety Analytics Service to you.

The monthly subscription fee for Safety Analytics Subscriptions shall be set forth in an Order Form; Subscription fees shall be per driver per month. You must be an active Trimble customer and have active Subscriptions under a Telematics Schedule to utilize the Safety Analytics Service. Fees for all Safety Analytics Service Subscriptions provided pursuant to this Addendum will be billed on a calendar month basis; fees for the month in which the Billing Commencement Date occurs will be prorated.

* Billable active drivers are billed in advance based on the number of active drivers in the Management Portal on the last day of the previous month. A CSA Data Provider intake form for data permissions must be completed as part of the enablement of the Safety Analytics Service.

** Trimble eDriver Logs must be contracted & activated in order for you to receive HOS violation data through the Safety Analytics Service.

*** Trimble Onboard Event Recorder must be contracted & activated in order for you to receive Driver Behavior data through the Safety Analytics Service.

**** Available pursuant to agreement between the CSA Data Provider and Trimble. We cannot guarantee the availability of the CSA Data Provider services. Downtime or unavailability of the CSA Data Provider’s systems shall not count as downtime under any applicable SLA or otherwise constitute a breach of the Agreement.

This Addendum is incorporated by reference into and is made a part of the Agreement. In the event of a conflict between a term or provision in this Addendum and a corresponding term or provision in the Agreement, this Addendum controls. Except as otherwise modified or supplemented by this Addendum, all terms, conditions and provisions of the Agreement shall remain in full force and effect.
